64/21 Welcome and Apologies

The Management Side Chair welcomed all to the meeting. There were no apologies.

65/21 Pay 2021-22

The Management Side thanked the EIS-FELA for attending this meeting and for also cancelling strike action for that day. It advised it would like to make a provisional offer of a £1,000 consolidated salary uplift on all scale points, subject to agreement by the College Employers Scotland (CES) Executive Group, and hoped that, once the offer is confirmed, the Staff Side would be in a position to suspend strike action and action short of strike. The Management Side stated that if no agreement could be reached on the revised offer,, then the previous offer of £900 consolidated and £150 unconsolidated would stand. It advised it did not have the mandate to make this provisional offer, however, felt that it would be able to reassure the CES Executive Group of the offer, if it would lead to the suspension of strike action.

In response, the Staff Side asked for clarification on the timing of the next CES Executive Group meeting.

The Management Side advised a meeting with the CES Executive Group was scheduled to take place on the afternoon of Tuesday 31 May 2022.

The Staff Side requested an adjournment.

Adjournment

Following an adjournment, the Staff Side advised if the offer of £1,000 is confirmed by the Management Side, it will put the offer to a ballot to members, as a way of encouraging CES Executive to agree to making the provisional offer formal.

The Staff Side further advised that as an act of good faith and whilst discussions are ongoing, the scheduled strike day on Wednesday 1 June 2022, will be suspended. The Staff Side requested the Management Side to ensure that lecturers will not be required to make up for work loss due to strike action on an unpaid basis.

The Management Side asked if the Staff Side will be suspending all industrial action, including action short of strike, during the ballot period.

The Staff Side advised once the Management Side confirms its provisional offer it will suspend all industrial action during the ballot process.
