20/16 Minutes of Previous Meeting

22/16 NJNC STL Pay Agreement – Application of the £100

The Management Side stated that it was is evident that both Sides had differing interpretations on the application of the £100 from the NJNC Pay Agreement. The Management Side stated that it believed that the Agreement had been honoured through their interpretation.

The EIS stated that it believed that the £100 had not been paid for 2015-16 in a consolidated manner and that members would be a £100 short by the end of 2016-17. The EIS asked the Management Side to amend it position on the £100. The Management Side stated that it wished to move on to other matters since no progress on this matter seemed possible.

The EIS indicated its intention to lodge a dispute within the NJNC regarding the breach of the Pay Agreement regarding the £100 and a breach of the NRPA.

It was confirmed that any formal agreements reached at the NJNC should be subject to a NJNC circular through the Joint Secretaries.

Following a number of adjournments, it was agreed to progress with the agenda.

23/16 National Pay Scales
